Dear Governor Kotek,

Westside Economic Alliance strongly supports your proposal to bring 373 acres into the urban growth boundary to better position Oregon to land one of the national semiconductor research and development centers.

As a nonprofit, member-based organization, WEA advocates for a vibrant economy on the Westside of the Portland metropolitan region. We work to create an economic landscape where our residents can both be part of a welltrained and well-paid workforce and live in thriving and healthy communities. We believe that this 373-acre expansion coincides well with our mission and providing strategic opportunity for Oregon to lead in the international semiconductor industry while strengthening the middle class in Oregon for generations to come.

The expansion of the urban growth boundary is vital for several reasons, here are just a few:

Economic Growth: It is time to move past the false notion that Oregonians can only either care about farm and forest OR economic opportunities that create middle class jobs. By positioning Oregon as a location for one of these semiconductor research centers, we open the door to well-paid jobs that will strengthen the middle class and increase tax revenue generation for our region and state. This expansion would benefit working families around the Portland metro area and across the entire state.

Global Competitiveness: As worldwide demand for semiconductors continues to rise, it is crucial that Oregon continues to position itself as a leader in this industry. Expanding the UGB will help attract further
